### **Purchase of Exclusive Rights Privacy Notice**

When you purchase the Exclusive Right to a single or joint cemetery plot:

The information you provide (personal information such as name, address, email address, phone number) will be processed and stored so that it is possible to contact you and to respond to your correspondence, provide information, send invoices and receipts relating to your burial plot/s. Your personal information will not be shared with any third party without your prior consent.

### **The Councils Right to Process Information**

Under GDPR Article 6 (1) (a) (b) and (c) (General Data Protection Regulation [Regulation (EU) 2016/679], Duxford Parish Council has the right to process information provided:

Processing is with consent of the data subject

or

Processing is necessary for compliance with a legal obligation

or

Processing is necessary for the performance of a contract with the data subject or to take steps to enter into a contract

### **Information Security**

Duxford Parish Council cares about ensuring the security of personal data. We make sure that your information is protected from unauthorised access, loss, manipulation, falsification, destruction or unauthorised disclosure. This is done through appropriate technical measures and relevant policies.

We will use your data only for the purpose it was collected and it will be kept throughout the period of your employment and for a statutory period of six years following. after which time it will be deleted.

## **Your Rights**

### **Access to Information**

Duxford Parish Council has a legal obligation to retain the personal details of owners of Exclusive Rights and Registrar consent for burial. This also includes cemetery information detailing the names of those buried or to be buried in the future within its burial grounds.

### **Rights Related to Automated Decision Making and Profiling**

Duxford Parish Council does not use automated decision making or profiling of personal data.

### **To Sum Up**

In accordance with the law, we only collect a limited amount of information about you that is necessary for correspondence, information and service provision. We do not use profiling, we do not sell or pass your data to third parties. We do not use your data for purposes other than those specified. We make sure your data is stored securely. We delete all information deemed to be no longer necessary. We constantly review our Privacy Policies to keep it up to date in protecting your data.
